ATA Martial Arts - The ATA Martial Arts Schools, The American Taekwondo Association, including its owners, instructors and students, agents or entities associated with ATA

Martial Arts - including but not limited to Takewondo, Krav Maga, Brazilian Jiu Jitsu

You, your - refers to the person entering into this agreement.

Liability Agreement

By participating in any programs at ATA Martial Arts you agree to the following:

You certify that you are fully aware of and understand the inherent dangers in participating in activities involving Martial Arts, and of basic safety rules and procedures of participation in Martial Arts events.

You understand and agree that ATA Martial Arts will not be responsible for your safety, nor will any of these parties or individuals serve as a guardian of your safety.

You understand and agree that ATA Martial Arts may not be held liable in any way for any occurrence or event in connection with your membership or participation in Martial Arts events which may result in injury, death or any and all damages to you or to your family, descendants, heirs or assigns.

You understand and agree that in consideration of being allowed to be a participant in events held in association with an ATA Martial Arts location, you hereby personally assume any and all risk involved in connection with such participation. Furthermore you release forever ATA Martial Arts for any harm, injury or damage that that may occur to you while you are a participant in a ATA Martial Arts program including all risks whether foreseen or unforeseen or risks/harm caused by negligent act (excluding gross negligence or reckless behavior). Furthermore, you will hold harmless ATA Martial Arts from any claim by you, your family, your estate, your heirs, your personal representatives, or their assigns, arising out of your participation in Martial Arts events.

You further state that you are of lawful age and legally competent to enter into this agreement, and that you are entering this agreement is your own free act (unless this is signed by a parent or legal guardian). You also understand and agree that the terms herein are contractual, and they are not a mere recital for information purposes.

You have read, and understood, and are fully informed of the contents of this agreement. You assume your own responsibility for your personal condition and capability to participate in the Martial Arts events.

Participant is a Minor

In consideration of the aforementioned activities, and as a parent or legal guardian of the minor to be participating in the aforementioned activities, you on behalf of said minor agree to indemnify and save harmless ATA Martial Arts against any claim for damages, compensation or otherwise on the part of said minor, or by his or her heirs, executors, or administrators and to reimburse or make good on any loss or damages or costs that any of the above parties may have to pay in full any litigation which arises on account of any claims made by said minor or anyone on his or her behalf. Further you release any claim or cause of action that you may personally have as a parent or legal guardian resulting from any such injury or death to said minor.
